

LMOGA provides representation in the Louisiana Legislature; local, state and federal agencies; and the U.S. Congress. LMOGA also frequently collaborates with other trade associations and affiliated organizations such as the OOC, NOIA and API. We have relationships with the news media and educational entities such as the LSU Center for Energy Studies.

Throughout the year, LMOGA monitors and facilitates meetings of state and federal government agencies such as the Department of Environmental Quality, Office of Conservation, the Department of Revenue, Louisiana Tax Commission, Louisiana Economic Development, the Mineral Board, Public Service Commission, and federal agencies such as Bureau of Safety and Environmental Enforcement (BSEE), Bureau of Ocean Energy Management (BOEM), Environmental Protection Agency (EPA), legislative committees and the special agencies, commissions, boards and committees formed to consider specific matters.





# **Energy Partner Dues**

The Energy Partner membership is based on the number of a company's full-time employees or gross sales revenue.

DUES AMOUNT	CRITERIA
\$2,500	Greater than 101 employees or greater than \$50,000,000 in gross sales
\$1,000	Between 26 - 100 employees or \$1,000,001 to \$50,000,000 in gross sales
\$500	Between 6 and 25 employees or \$250,001 to \$1,000,000 in gross sales
\$250	Less than 6 employees or less than \$250,000 in gross sales

# About GEST

#### What is GEST?

The Gulf Economic Survival Team (GEST) is a 501(c)4 non-profit grassroots advocacy organization and is a subsidiary of the Louisiana Mid-Continent Oil & Gas Association (LMOGA). GEST is a membership based association with membership opportunities available for the oil and gas industry service companies and individuals based on an annual membership fee. GEST members are classified as Energy Partners to LMOGA and have the opportunity to participate in just about all of the meetings and events hosted by LMOGA. GEST serves as an umbrella organization to other member organizations and nonprofits, such as the South Central Industrial Association, Bayou Industrial Group, Houma-Terrebonne Chamber of Commerce and the Lafourche Chamber of Commerce. City and Parish governments as well as other government entities, such as ports and levee districts, also have the opportunity to serve as adjunct members in support of GEST's efforts.

GEST promotes the significance of the energy industry in the Gulf Region to the U.S. economy, small service companies, and middle-class Americans throughout our great nation.
